WHAT AN EXCITING YEAR it has been for South Enotah Child Advocacy Center! This was our first full year of operation after launching our organization in the summer of 2016 and we have been able to reach quite a number of milestones. With the help of the communities in Lumpkin and White Counties we succeeded in raising over \$50,000 in public support. In particular, we want to thank the Sisters of Kappa Delta Sorority at the University of North Georgia who chose us as the beneficiary of their annual Run Dahlonega 5K that raised over \$27,000 and the 2017 Class of Leadership Lumpkin whose golf tournament organized on our behalf raised nearly \$16,000 and set the stage to make this an annual event. The public support that was secured enabled us to hire Cheyenne Thornton as our first Executive Director and served as local matching funds to support our grant applications. We applied this year for several grants and among those that we were awarded were a Promoting Safe and Stable Families contract from the Georgia Division of Family and Children Services in excess of \$35,000 and a Victims of Crime Act grant from the Georgia Criminal Justice Coordinating Council for more than \$112.000, These operating funds will allow us to provide the children that we serve and their non-offending caregivers with a variety of support and treatment including family advocacy services, parenting education, and trauma-focused counseling services.

FROM THE START our partnership with the University of North Georgia has made it possible for us to provide our communities with much needed services. UNG has graciously shared their Clinical Mental Health Counseling facility with us and the graduate students in that program have provided counseling services to our children and families. As both we and the UNG program have grown, the need for a facility that we can call our own and that will allow us to consolidate all of our services under one roof has become evident. Securing our own home will be a major objective for 2018.

IN CLOSING, let me thank everyone who has supported us this past year and invite all of you to join in our efforts to support the children and families of Lumpkin and White Counties!

OUR JOURNEY

The South Enotah Child Advocacy Center is a 501(c)(3) not-for-profit corporation established in 2016.

The Center grew out of the efforts of a group concerned citizens, law enforcement personnel, and child protective services professionals in both Lumpkin and White Counties wanting to better serve the victims of child abuse and to enhance and expand their child abuse education programs and prevention awareness efforts. After learning that each other's efforts to establish a child advocacy center were also already underway, the two groups quickly made contact. Soon thereafter, the groups agreed to combine efforts and begin working collectively to establish a single, enhanced child advocacy center chartered to serve both counties.

The Enotah District Attorney's Office, already acutely aware of the need in both counties, provided the funds to incorporate The South Enotah Child Advocacy Center and worked to secure the Center's 501(c)(3) status.

INTERVENTION

FORENSIC INTERVIEWS

A forensic interview is conducted at the SECAC when there has been a report to either law enforcement or the Department of Family and Children's Services (DFCS) that the child may have been a victim of physical or sexual abuse or when a child may have witnessed a violent crime.

Forensic interviews are conducted by our forensic interviewers who have had at least 40 hours of specialized training on how to properly question children. The forensic interviewers also routinely participate in peer review meetings to continually develop their skills.

All forensic interviews at the South Enotah Child Advocacy Center are video recorded.

FORENSIC MEDICAL EXAMS

A Forensic Medical Exam (FME) is a specialized medical exam conducted by a professionally trained, certified sexual assault nurse examiner utilizing specialized equipment for accurate diagnosis and evidence collection in a child friendly environment.

They are conducted when a child has disclosed sexual or severe physical abuse and the exam is deemed necessary.

Exams are tailored to the statements made by the child in the forensic interview and are used for evidence collection, testing, and treatment.

PARENT EDUCATION

A seven-week program (once per week) in which a SECAC Family Advocate teaches a parent effective parenting techniques for young children or teens. At the end of the course, parents have a better understanding of themselves, their child, how to listen and respond, foster cooperation, and discipline effectively.

After completing the program, participants meet every other week with a group working to reinforce and effectively implement the techniques learned during the seven-week course.

FAMILY ADVOCACY

The Family Advocacy Program provides services to non-offending caregivers of children interviewed at the South Enotah Child Advocacy Center. A Family Advocate will meet with the non-offending caregiver while their child is being interviewed to assist with resources in the area as well as answer any questions they may have.

- Crisis Intervention.
- Referrals for counseling or any other services needed (i.e. domestic violence shelters, parenting classes, protective orders, housing, etc.)
- Information about victim rights and crime victims' compensation.
- Information about the child protection and criminal justice systems.
- Education about age appropriate sexual behavior.
- Follow-up support and help as needed.
- Anything else that may be requested by the non-offending caregiver.

THERAPY

The South Enotah Child Advocacy Center is a proud partner with both the UNG Clinical Mental Health Counseling Clinic and Turning Points Counseling to provide high quality therapy free of charge to children and their families in Lumpkin and White Counties who have experienced sexual abuse or severe physical abuse.

MULTI-DISCIPLINARY TEAM RESPONSE

The MDT team is composed of representatives from law enforcement, child protective services, the District Attorney's Office, medical field, mental health field, and SECAC staff. These representatives work together to coordinate intervention in order to reduce potential future trauma for children and their non-offending caregivers.

We recognize that child abuse is a multifaceted issue, and no single agency or individual has the necessary knowledge, skills or resources to serve all the needs of victimized children and their families. SECAC brings together wisdom and knowledge from professionals of different disciplines, which results in a better understanding of case issues and an effective child-focused response.





In addition, Krista provides clinical supervision and mentoring to mental health professionals, testifies in criminal, civil and juvenile court settings as an expert witness in child abuse and sexual assault cases, and conducts workshops, lectures, and clinical consultations for individual practitioners and community organizations across the State of Georgia.
